On 1 Apr 69 at 2054 hours the recon platoon reports that when 1/35th was receiving incoming rounds they were monitoring the air ground push and heard some VC/NVA speaking and swore they heard the word fire used several times. They also reported at 2054 hours that they were monitoring the air ground push and heard VC/NVA whispering. At 1751 hours on 1 Apr 69 D Company reported as its 52A element was moving the hook was fired on by AK-47s and possible automatic weapons 20 degrees and 300 meters away. They are currently firing Redleg.

0005 hours (C) To Bde: B Co 3rd plt will be going to Rock Quarry; D Co 3rd plt will go to Old Plei Djereng.

1132 hours (C) Bde to Bn: B Co 3rd platoon is now OPCON to 1/10 Cavalry.

1330 hours (C) To Bde S-3 from Bn S-3: Request airlift to move men of C/1/35th from LZ English to ZA017713. Request to move 22 men of C/1/35th from LZ Bobbie to ZA017713. We can concurrently move 90 men D/1/35th from ZA017713 to LZ English tomorrow.

1542 hours (C) D Co 52A element is located at ZA016772 and reports they hear movement at their objective location which is ZA015724. They are going to pull back a couple of hundred meters and employ Redleg.

1613 hours (C) LZ English is receiving incoming rounds: 3 rounds type unknown and possibly 2 AK-47s.

1640 hours (C) U.S. Forward Observer with CSF informs us that tanks are firing on them. He contacted 1/69 and they were instructed by their higher to recon by fire as they went through the area where contact was made about 1 weeks ago. Forward Observer reports negative casualties, informed Tank armor to let us know when he reaches LZ Bobby. Then we will keep a radio on the tank push. Also Bn CO informed tank armor of all friendly locations.

2054 hours (C) Recon platoon reports that when 1/35 was receiving incoming rounds they were monitoring the air ground push and heard some VC/NVA speaking and swore they heard the word fire used several times. They also reported at 2054 hours they were monitoring the air ground push and heard the VC/NVA whispering.

2055 hours (U) DELAYED ENTRY- 1 Apr 69 at 1738 hours a message from recon S-2 and Co line number 97 said that the line number was a WIA and became a KIA at 1045 hours. This was confirmed.

2066 hours (U) DELAYED ENTRY- 1 Apr 69 at 7151 hours D Co reported as its 52A element was moving the hook was fired on by AK-47s and possible automatic weapons 20 degrees and 300 meters. They are currently firing Redleg.

1754 hours (C) B Co reports hook receiving 2 bursts of AK-47 fire. It was 3 to 20 degrees radius and 3 kilometers away. There were a total of 20 rounds.

2146 hours (U) DELAYED ENTRY- 1 Apr 69 at 1820 hours D Co reports its 52A element SRP saw movement of unknown size and force to their north. They are employing M-79 fire and are adjusting Artillery on the area.

1015 hours (C) B Co's dog handler says his dog ran head on into a deer and hurt his leg. He would like a replacement.

1105 hours (C) CSF at ZA069687 took small arms and an M-79 from ZA053674 and saw one friendly WIA who fled west.

1715 hours (C) To TOC from B Co: 8 C-rations per man. All weapons have been inspected except the 1st platoon which had 122 rounds of 81mm HE, 3 rounds of illuminations and received 5 bags of mail and A rations. The plans are to continue to do what I have been doing. The CO went to investigate and there turned out to be 12 Montagnards. He sent a platoon to police them up and found out what they were doing. S-3 requested that they be policed up. At 1756 hours on 5 Apr 69 B Company reports the 53rd element ran into a trail heading south. They found 4 packs at ZA039707 and upon hearing movement went to high ground. They spotted 2 VC/NVA (040707), opened up fire on them and thought they killed one. They employed artillery and organics as a blocking force. VC/NVA headed into a gully. The element was getting fire from 3 sides. As a result there was 1 friendly WIA line #163 of the March roster. He was wounded in his right side. At 1840 hours on 5 Apr 69 A Company reports 01 Bushmaster moving toward its night location and running into a VC/NVA at ZA048705. The short range patrol opened up fire on him and

he was confirmed as a KIA. This WIA wore a green shirt, loincloth, 1 pistol belt, 3 magazines full of US M-26 rounds. He was running west to east. At 1925 hours 5 Apr 69 B Company reports VC/NVA were wearing gray shorts and short sleeve shirts, carrying AK-47s and no web gear, no hats, no sandals.

0951 hours (C) B Co reports at 039711 that they found a dead VC/NVA in a grave and also 1 Chinese Communist grenade. VC/NVA was estimated 1 month being dead and his death was from small arms of another in khaki shirt, pants.

At 1342 hours 6 Apr 69 A Company reports that they are in contact at ZA056688 and the lead element spotted 4 VC/NVA in the open 30 feet away wearing tiger fatigues and carrying weapons. The company fired on them and they fled in an unknown direction. A Company is maneuvering to surround them. At 1421 hours on 6 Apr 69 A Company further readout and spotted by the 52 element were 4 VC/NVA on the east side of the blue line. They engaged them and the enemy fled across the stream and south. The element saw 2 more on the east side of the blue line and they were believed to have fled northeast. flashlight (BA-30s US world type and some unknown), mess gear, pair of Ho Chi Minh slicks, 3 U.S. maps sheet 6637 IV and sheet 6638 III and 6536 (?). there was Duc Co in writing on map GI L971 and also found were 1 mosquito net U.S. type, 30 AK rounds.

0906 hours (U) DELAYED ENTRY On 6 Apr 69 at 0850 hours B Co 2nd platoon and 3d platoon have linked up. They also found 2 AKs at ZA039706, 1 Chinese AK with blood on it and the other a Russian type. Both had loaded magazines in them with 3 to 4 rounds. B Co 3d platoon is organizing a sweep in that area.

0900 hours (C) A Co SRP 02 ZA056702 found what they believe to be a NVA graveyard which had 4 corners marked with graves inside. Bn S-3 informed them to dig up some but be extremely careful.

1342 hours (C) A Co reports they are in contact at ZA056688. A co the lead element spotted 4 VC/NVA in the open about 30 feet away wearing tiger fatigues and carrying weapons. A co fired on them and they fled in an unknown direction. A Co is maneuvering to surround them.

1400 hours (C) A Co reports they spotted 1 weapon in the open and they are trying to rundown the individuals who fled.

1421 hours (C) A Co further readout: 52 element spotted 4 VC/NVA on the east side of the blue line. They engaged them and the enemy fled across the stream and south. The rounds impacted 75-100 meters from the element and approximately 35 AKs fired 100 rounds and more. At 1100 hours on 26 Apr 69 B Company's 51 element has found a total of 5 caps for a 60mm mortar in location 123357. At 1130 hours on 26 Apr 69 A Company spotted an individual in green fatigues about 500 meters from our location of 135342 moving south along the lake and no weapon was spotted. At 1135 hours B Company on 26 Apr 69 said that mortars were not dug in and there were no base plate markings. The area was in an opening and there was a trail 100 meters away running east west. At 1420 hours on 28 Apr 69 C Company found what they believed to be an old French mine field, approximate location of ZA097343. They estimated 30 to 40 Bouncing Betty type mines. At 1755 hours on 28 Apr 69 the Engineers reported the mines were the said type (M2 series, US type and fairly new). Trip wires on the mines were burned off in one area of the field and it contained 7 mines. Estimated size of the field was 200 by 50 meters. Mines were on both sides of the field and S-3 1/35th asked Bde if the field was to be marked or destroyed. At 1830 hours S-2 reports that at 0900 hours Plei Me CSF found a cache at ZA172199. It contained documents, ID cards, 3 Chinese Communist grenades, 1 shotgun, and 1 carbine. At the same grid around 1200 hours the CSF had contact with 5 to 6 individuals. Contact was broken at 1215 hours and the enemy evaded to the northwest direction. At 1218 hours the Forward Air Control came on station, no artillery was employed.
