Size of hooch was 5 long by 3 width by 3 high and it was made of bamboo and pick command engineer stakes. The Recon platoon found 50 to 300 lbs. of unfinished rice in the hooch with a great deal of sandbags. At 0838 hours the Recon platoon found a hooch and a rice hooch 50 meters southeast of ZA163217. It could store 500 lbs. of rice and was 6 by 4 above ground. Inside they found 4 GI sandbags of rice and 1 gourd of corn. The hooch was new, used within the last 2 weeks. At 1359 hours on 1 may 69 the Recon platoon found a small cave at (ZA169218), 300 or 400 meters of that cave they found a trap 6 feet of bamboo sticks sharpened and spring loaded. The trap was set about waist high.

As soon as the 63 element gets back to its CP they will send a diagram of that trap. Location of trails and traps is ZA235088. At 1055 hours on 3 May 69 B Company's 61 element found 5 hoochs and 2 of them were new, 1 was being made, 2 were of medium age and of size 4 x 6. Inside they found 50 lbs. of rice and 50lbs. of corn. At 1103 hours on 3 May 69 C Company at location ZA243065 found a tunnel complex of 20 caves. Size of caves was 3 x 5 x 5 and entrance was 3 by 2 in diameter. They were about 2 months old and were not used. Water holes nearby the caves were dug into the side of the hill not shown on the maps. At 1335 hours on 3 May 69 B Company found 1 bunker 6 x 4 x 6 deep and no overhead cover, no recent use. They found 2 glass jars, 1, 2 and 3-gallon jars at location ZA226084. At 1200 hours on 3 May 69 the 3rd platoon of D Company found 2 sleeping hoochs and one spider hole vicinity ZA228079. Hoochs were approximately 12 by 20 and 4 high containing sleeping mats and holding 10 persons in the prone position. (10 accommodated) Age of them was unknown and also found was a pile of ashes from a wood fire, bundle of punji stakes, pieces of bamboo 2 in diameter with illegible charcoal handwriting. An 18' spider hole was also found in the same vicinity, no recent use. Approximately 150 meters northwest and on the west side of the river 3 tunnels 5 feet lone were found and the entrances were 2 feet in diameter. One contained a Montagnard type jug, another 15 pounds of loose unpolished rice, the third was collapsed. On the west side of the river one more hooch 4 by 6 was found in a cultivated area containing one crossbow. Next to the river were one US pistol belt (new) with one worn and old canteen cover, canteen, M-26 had frag grenade attached to the pistol belt. At 1305 hours on 3 may 69 B Company 63 element found 20 rice hoochs 4 x 6 with woven mats, bamboo at ZA225090. They also found hoochs at ZA225093. 63, 632 are keeping it under surveillance.

Cacti Blue LZ Attacked; 18 Enemy Killed

An American Reconnaissance Team Saw Three Individuals Approaching The Company Perimeter. They Waited Until The Three Enemy Soldiers Were Within Eight Feet And Then Opened Up With Their M16s.

Highlander Heights- Bravo Company, 2nd Battalion, 35th Infantry repelled a night attack killing eighteen enemy attackers ten miles southwest of Kontum City near Landing Zone (LZ) Penny. At 1:50 in the morning, an American reconnaissance team saw three individuals approaching the company perimeter. They waited until the three enemy soldiers were within eight feet and then opened up with their M16s killing all three.

These three NVA soldiers however turned out to be only a probe for the main attack, which began on hour later when Bravo Company was suddenly hit with incoming. They were firing B40s and recoilless rifles from 25 to 30 meters out, said Specialist 4 Vaughan Connors of Cincinnati. We turned everything we had on, and called in artillery, mortars and Snoopy gunships. I guess that was too much for them and they took off.

During the 35 minute fight Bravo Company received an estimated 75 to 100 incoming rounds, as well as small arms fire.

A sweep outside the perimeter in the morning turned up eighteen enemy bodies, one AK47 rifle with ammunition, seven CHICOM grenades, and one new B41 launcher with five B41 rounds.

At 071930 hours the 2/1 Cav received small arms fire and approximately 57 and 75 rounds of fire from unknown size force vicinity AR948203. They engaged the target with Spooky support. They estimated a Company size element and contact was broken at 2040 hours. They found a large cache of munitions. At 1150 hours on 8 May 69 D Co 70B element spotted 2 individuals at ZA052381. When the 2 saw the element they hit the ground. They were assumed as enemy carrying carbines and a check with Bde revealed no friendlies in the area. They fired and no fire was returned from the enemy. At 1211 hours 8 May 69 the element told Bde

S2 that the 2 individuals wore uniforms of the camouflage type similar to the type worn by LRRPs. Enemy was moving in a northeast direction and distance was approximately 50 to 75 meters away. The area is being swept now with no results.

0005 hours (C) From S-3 to B Co: Be ready for pick up at 0700 hours at PZ ZA103321. You will be inserted at LZ AR965215, maps are available from 2/1 Cav and frag 65.10, call sign: above times. Your mission is to sweep east of the LZ, and a company of the 2/1st Cav will be on the LZ, which is secure. At 0130 hours on 9 May 69 D Company reported they received a VC probe and estimated that they also received 4 grenades and 1 magazine of AK fire. The probe came from north, northwest and the company had 5 WIA, 3 not too serious, 2 a little more serious and may need a Dust-Off. The OPs reported hearing negative movement. At 0730 hours on 9 May 69 D Company found 2 holes that were made by a B-40; one on the perimeter and one inside the perimeter. They found 1 new B-40, 2 Chinese Communist grenades (1 was a dud) and 1 explosive package with a fuse. As a Delayed Entry D Company at 0710 hours on 9 May 69 received small arms fire and B-40 rocket rounds at vicinity ZA056402. 3 Rockets rounds landed one outside of the perimeter approximately 50 meters and the other one landed inside of the perimeter. One round hit a tree at a height of 20 feet and caused a friendly casualty. They estimated 4 to 5 enemy individuals involved in the attack. During a

sweep of the area at daylight they found 1 new B-40 Rocket, 1 Chinese Communist grenade (frag) complete, 1 explosive pack with fuse, a home made bomb about 2 inches square by 4 inches long with an acid type fuse which did not explode, approximately one or two AK-47 magazines. At 1035 hours on 9 May 69 D Company reports finding 2 cans of material vicinity ZA056402. One can was a M60 type and the other was an M-16 type. Included in the material was some 30-caliber ammo, box of rice, 2 boxes of documents with the name of 2 villages (local) written on them. The number B7 is frequently mentioned in the documents and the Company was told to evacuate to the Bn Command post all material. At 1050 hour on 9 May 69 the Recon plt at ZA079217 was located with the CIDG team. The team was told that the village people quessed they received 4 rounds of mortar or B-40 rounds, which came from the south or southwest. At a later time comments were made by Brigade S2. The 1/39 RF Company made contact with an unknown size VC force. They received 3 to 4 rifle grenade rounds vicinity ZA085206 and returned the fire. Contact was broken at 1005 hours with unknown enemy casualties. No friendly casualties resulted. At 1125 hours on 9 May 69 D Company found 2 Chinese Communist grenades, 1 bottle of rack salt, 1 dead python snake 8 feet longs approximately 50 meters north of their location of ZA056403. At 17109 hours on 9 May 69 C Company 70 element spotted 1 individual 100 meters east. They fired at him and he fired back. headed east. There were no blood trails or equipment at the contact site. He was wearing pants the type unknown. ZA085401.

0107 hours (C) D Co reports they just received mortar fire and small arms on the CP location ZA056402.

0115 hours (C) D Co reports they believed they received frags instead or mortars and they have casualties.

0210 hours (C) Lt. Clark from Bde TOC: Were Arty or organic mortars employed by D Co? Ans: No, on Arty, C Battery could not reach it and there was a gun target problem from the Rock Quarry. Also, mortars and Arty were not employed due to D Co troops being spread over the area and the Co did not know which way the enemy fled.

0344 hours (C) D Co now reports they have 9 wounded instead of 5 with line numbers: #8 leg, #15 hand and hip, #36 head and hip, #47 hip and back, #58 upper arm and above eye, #60 shoulder, #62 cheek, #86 leg, #104 leg.

0423 hours (C) We sent wounded men's line nos to Bde and Lt. Clark wanted to know the disposition of the troops.

0427 hours (C) D Co says troops are sleeping outside of the holes with 4 men to a hole and the perimeter is a circle.

0801 hours (U) DELAYED ENTRY on 9 May 69 at 0710 hours D Co received small arms fire and B-40 rockets and rounds vicinity ZA056402. 3 B-40s landed outside the perimeter approximately 50 meters. They estimated 4 to 5 enemy and on a sweep of the area at daylight they found 1 new B-40 rocket, 1 Chicom grenade frag type and complete, 1 explosive pack with fuse, (home made

There exists the possibility of commitment to the 2nd Bde TF formed to reinforce the 24STZ in Ben Het area.

2052 hours (C) From Bde To TOC: 1/10 Cav element at 2015 hours received mortar rounds and AK fire from Vicinity YA975427 and returned small arms fire.

Earlier this evening the Rock Quarry had some movement and C 2/9 fired some arty for them, they will also fire a night program for the Rock Quarry in grid square 0529. Some dud rounds at the Rock Quarry will be disposed of tomorrow. At 0805 hours on 13 May 69 B Company 1st platoon (Coordinate ZA089270 found 10 bunkers, overhead cover, had small dead logs and bushes and no earth, size was 2 x 3 x 4, also found were 25 75mm recoilless rifle canisters (OD colored) and 2 firing positions. At 0905 hours 13 May 69 C Company saw 4 men 100 meters away with weapons moving from south to northeast (vicinity ZA004205). B Company's 2nd platoon engaged them with small arms and M-79. The enemy fled to the northeast and B Company is now planning an artillery and mortar program. At 1750 hours on 13 May 69 B Company's 2nd platoon saw 3 men fully dressed in khaki uniforms, not armed and were located at (coordinate ZA104227) 300 meters due south. At 1920 hours A Company's 3d platoon in reference to B Company commander's question on enemy casualties: During the incoming period at the Rock Quarry last night, trip flares were set off by 2 individuals entering the perimeter; one was shot, he fell to the ground while the other got away. One hour later the one that was shot disappeared to the east side of the Rock Quarry perimeter. At 1913 hours on 13 May 69 B Company requested a Dust-Off for 5 enlisted men 2 litter, 3 ambulatory category urgent and ETA is 20 minutes. Dust-Off 36 had injuries due to friendly 81mm mortar fire. 0045 hours (C) From TOC to B Co: Have your medic SP4 Allen to come back to this location he is going to A Co.

0105 hours (C) Cpt. Smith to A Co: He informed the Co to have 4 EM and Lt. Mahifry ready to go to the Rock Quarry tomorrow at 0700 hours.

0236 hours (U) DELAYED ENTRY On 13 May 69 at 0230 hours 35B to fragment TOC wanted to know the situation at the Rock Quarry: Ans: Men thought they heard movement. One threw a frag, which set off a trip flare and a claymore. They saw a figure that looked like a man and fired on it. They do not know if the was wounded or not.

0800 hours (C) B Co to TOC: Our 80 element at ZA089270 found in this location 10 bunkers with small dead logs, bushes, no dirt for overhead cover. Size was 2 x 3 x 4, 25 75RR canisters OD color, 2 firing positions. All these were found within 20 to 30 meters of the location given. B Co says they could see the fixed wing pad from both locations of firing positions.

0905 hours (C) C Co spotted 4 individuals 100 meters with weapons moving northeast from south vicinity ZA004205. The 16 element employed small arms and M-79. Enemy fled to the northeast and the Co is planning Red Legs and light organics.

1055 hours (C) To C Co and Recon from S3: 1/10 Cav in vicinity of grid 0324 found foot prints of approximately 25 individuals moving south, southeast directions. At 0205 hours on 14 May 69 bunkers 4 and 5 engaged the enemy, they fled to north. Enemy was outside of the wire and friendly troops did not observe weapons on them. Place of above action was LZ Oasis. At 0213 hours 14 May 69 we informed B Company (coordinate ZA093246) on receiving incoming and they should remain alert. At 0850 hours 14 May 69 (vicinity LZ Oasis) a vehicle designated to perform

trash detail took 2 rounds of sniper fire (vicinity Trash dump). At 1130 hours, the 3d platoon of B Company (at coordinate ZA125283) found a B-40 cap, one sandal and a bloody cloth. Presence of wounded enemy was suspected in the area, however, Scout dogs were unable to pick up a scent from the cloth. At 1245 hours on 14 May 69 B Company discovered that one EM had a small piece of shrapnel in his left cheek which was caused by friendly mortar fire 131913 May. At 1345 hours on 14 May 69 C Company water patrol saw one individual with a weapon and fired small arms at him. They do not know if the wounded him or not. At 1608 hours on 14 May 69 3rd platoon D Company (vicinity coordinate ZA008232) activated a booby trap, which was not on a trail. It wounded 8 men and of the 8 men 5 were litter patients and three were ambulatory. At 1700 hours on 14 May 69 the readout said the trap previously mentioned was a claymore mine set up by the enemy. At 1724 hours on 14 May 69 D Company reported 8 WIAs and 1 KIA. At 1743 hours on 14 May 69 D Company reports that they have a total of 9 WIA and 8 of ours and the dog handler is KIA. At 1900 hours 14 May 69 the aid station informed us that the dog handler is also KIA. Late entry Battalion S3 informed TOC that upon arriving at D Company's location, he did observe another booby trap with wires placed between two trees. It was estimated to be a possible helicopter booby trap located in the general vicinity of ZA008261. D Co 3d platoon reports their location as ZA008232. At 1704 hours on 14 May 69 the S4 resupply truck driver reported at 1345 hours while enroute to the Rock Quarry vicinity ZA074304 he was fired at with automatic weapons or possible 50 caliber fire which came from the south at a distance unknown. Small arms fire was returned with undetermined results. At 2112 hours on 14 May 69 B Company 70 element observed 25 to 30 enemy (vicinity ZA146285) moving northwest. The Company is planning artillery at this time.

0755 hours (C) To CO of Co B: Move one plt to vicinity LZ Oasis as soon as possible to follow blood trails and drag marks east from the Oasis perimeter. (B) Send 1 other plt sweeping east from the present location to drag valley vicinity of coordinate ZA120233 then northeast along the valley to establish N/Ls vicinity of coordinate ZA157270. (C) Move CP weapons plt and remaining rifle plt east to vicinity of coordinates ZA130250. Establish a patrol base and conduct daylight sweep, night ambushes of the route into and away from Oasis.

0800 hours (C) To CO of D Co: 1. Sweep northeast from present location along the likely routes of enemy movement into and away from the Oasis area. 2. Occupy blocking ambushes at the following location tonight- ZA034239, 023239, 010239, 000240, YA998244 and 995253.

approximately 30 minutes.

1813 hours (C) B Co reports at ZA105251 movement to the east 75 meters. They have coordinated with Recon and are now reconning by fire with M-16 and M-79.

Eyewitness Statement

On 14 May 1969 at approximately 1600 hours. 3rd Platoon, D Company, 1st Battalion, 35th Infantry was walking down a very old trail on our way to our night location. While walking down the trail the second man in line stepped on a claymore detonator. The claymore was about eight feet up the trail pointing down the trail. It was aimed waist high. It wounded eight men and killed two men. The scout dog was also killed. The dog handler and dog were third in the line of march. I don't know if there were any trip wires used. I do not know the reaction of the men who were wounded. The two men were killed by pellet and fragments from the mine.

At 1005 hours on 15 May 69 the readout on the enemy that B Company saw at 2112 hours said they found a trail (vicinity ZA145285) leading northwest and also to the blue line. 6 to 8 individuals went into the village located at coordinate ZA131292. The remainder continued northwest. At the blue line crossing they found barefoot tracks. Ho Chi Minh sandal tracks, did not see any weapons but heard a noise that sounded like metal. Late entry C Company at 1050 hours found an NVA Base Camp (new) 100 meters north of grid ZA040209. There were 6 bunkers 4 x 6 capable of holding 6 to 8 persons, occupied from 2 weeks to a month (estimate), well camouflaged with overgrowth and bamboo. They also found a top GI shirt pocket with unknown stains. A trail led from the bunker area to the blue line. Bunkers were recently used (approximately 5 days ago) and had steps out into the entrance. At 1320 hours C Company 3rd platoon at coordinate ZA033233 found 15 NVA bodies, approximately 2 months old, in fighting positions, little dirt thrown over them, no skin or flesh on the bodies. They also found 3 new B-40 rockets, 2 Chinese communist grenades, 1 NVA pack with all equipment, a downed LOH which they could not identity. They destroyed the bunkers and pack with contents (Answer to question from TOC concerning destruction of equipment). At 1907 hours on 15 May 69 a list of the pack contents was sent in. At 2141 hours on 15 May 69 B Company 70Y element had movement to the north, this side of the blue line, seemed to be moving towards the 70 (-) 3d platoon. Size of enemy movement was undetermined. At 2203 hours on 15 May 69 B Company employed artillery to divert the enemy towards 70Y 3d platoon position (vicinity ZA149285). At 2237 hours on 15 May 69 B Company ended the artillery mission. Also dogs were disturbed in the village and this indicated the enemy ran northwest into the village (coordinate ZA131291).

1005 hours (C) B Co to TOC: Readout on the spotting of individuals last night: The Co found a trail at ZA145285 running northwest, running to the blue line. 6 to 8 individuals went into the village at location ZA131292. The remainder continued northwest at the crossing of the blue line. The Co seen barefoot tracks, Ho Chi Minh tracks but did not observe any small arms. Individuals were carrying something that made a metal noise.

1100 (C) DELAYED ENTRY On 15 May 69 at 1050 hours C Co reported to TOC. They found an NVA Base Camp (new) 100 meters north of grid ZA040209. They found 6 bunkers with 2 feet overhead cover. Size was 4 x 6 and would hold 6-8 individuals. It appeared as though people stayed there 2 weeks to a month. All bunkers were well camouflaged with overgrowth bamboo and they found an upper breast GI shirt pocket with unknown stains. Estimated use of the bunkers was 5 days ago. A trail ran to the blue line from the bunkers and steps were cut in the entrance of recent use. No one saw the bunker in that area and the Co wants to check the whole area out more thoroughly.

1222 hours (C) D Co has a man whom has a medical breakdown and we request to have him brought in. Ans: We are trying to get an LOH.

1320 hours (C) C co from 18 and 16 element found at location ZA033233 15 NVA bodies approximately 2 months old (bones), 3 new B-40 rockets, 2 Chicom grenades, 1 NVA pack with all equipment. Bodies were found in fighting positions with a little dirt thrown over them. Also found was a downed LOH and it was beyond identification. Bodies were completely bones, no skin or flesh. We request someone to come her to identify the LOH.

1415 hours (C) Passed to A, B Cos: The enemy may attack by fire, or attack with ground probes, ground attacks are likely within next 24 hours.

1542 hours (C) From Bde S2 to Bn S2: There are strong intelligence indications of a planned enemy attack during the next 72 hours Sapper ground and attack by fire can be expected in the 3d Bde AO.

1548 hours (C) 1st PZ for D Co.

1617 hours (C) Bde informed us that when the CA for D Co is complete they are to secure the LZ and not move due to a possible move again to another area.

Recon is OPCON to B Co.

Recons Reflexes Are VC Downfall

Oasis- 25 May 1969- The quick, well trained reflexes of an infantry reconnaissance platoon were the downfall of a Viet Cong (VC) squad of eight operating 10 miles west of Camp Enari. The recon platoon from Echo Company of the Famous fighting Fourth Divisions 1st Battalion, 35th Infantry, discovered eight VC dressed in both green fatigues and black pajamas and equipped with weapons and rucksacks. The enemy squad emerging from a woodline 100 meters south of the Cacti Green platoon was traveling southwest along a stream bank. Without hesitation the recon element reacted before the surprised VC could respond. Small arms fire was employed, resulting in four enemy killed and the detention of one VC suspect. Captain James Scott of Coleman, Tex., battalion S-3, observed the conflict from a Light Observation Helicopter (LOH) and commented, It was the alertness of the platoon members that enabled us to engage the enemy squad without taking any injuries. Our recon element noticed that the eight enemy suspects were walking into an open area, continued Captain Scott, and they readied themselves before small arms fire was exchanged.

1628 hours (C) From Recon to TOC: At Za088357 found 5 bunkers 7 to 10 months old. Have 2 to 3 ft of overhead cover. Each bunker will hold 2 to 3 people, could have been used recently because there are no cobwebs. There is a trail running east and west at this location.

1635 hours (C) From D Co to TOC: 80A at ZA957295 received S/A fire from ZA970293 on edge of the village. Received 2, 10-12 round bursts, in a space of 45 seconds and rounds landed within 15

meters of my element. Moved element out of vicinity of fire. We were not able to fire back because of the village.

1708 hours (C) From D Co to TOC: 80A received about 5 more rounds of S/A fire from the village, sent the 80 (-) (1st plt) to vicinity immediately to possibly block off people who are firing. We are going to move through the village.

1845 hours (C) From B Co to TOC: 1st plt while moving to their N/L came across a clearing and spotted an individual 15 meters to their north on a trail at ZA009249. He was wearing green fatigues but could not determine if he had a weapon. They immediately took him under fire. He fled north up the trail and they reconned the trail by fire and swept the area with negative findings.

1930 hours (C) From S-3 to CO of A Co: You will be extracted to the Oasis airstrip tomorrow for a new mission southwest of the Oasis. You will be given 1 day tomorrow for showers, haircuts, hot food, etc., and will move out by foot tomorrow night. I need a proposed PZ for your Co and the earliest possible time you can be extracted (NLT 0930 hours earlier if possible.

2015 hours (C) From Recon, hears tubes popping azimuth 90 degrees, 1 click.

2015 hours (C) From C Co to TOC: Recon probably hears us. We had movement on the perimeter south between us and the blueline. Fired M-79s, will keep posted.
