0805 hours (C) Pleiku sending out Bikini gunships.

0808 hours (C) From B Co to TOC: My CP location received 20 - 25 rounds 60/82mm mortars. 2nd platoon element received 20 to 25 rounds 60/82 mortars. 3rd platoon received 15 to 20 rounds 60/82mm mortar plus automatic fire from 3 different directions. 49 element has 12 wounded, 10 to be dusted off. 0840 hours (C) From Pleiku: Requested Pink Panther guns.

0845 hours (C) B Co to TOC: 6 have been dusted off and they have 6 more WIA, 2 KIA to be taken out.

0855 hours (C) B Co to TOC: Dust-Off complete.

0900 hours (C) Bde CO inbound to our location.

0900 hours (C) TOC to Bde: Red leg being employed as blocking fire.

0915 hours (C) B Co to TOC: Total 12 WIA, 2 KIAs dusted off.

1141 hours (C) D Co 1st PZ.

1147 hours (C) D Co 1st LZ.

1234 hours (C) On final LZ for D Co the last bird was going in on the final LZ and received ground to air fire. He turned toward 71st Evac Hospital and received ground to air fire again. He then came to LZ Ruth. Aloha 05 took two injured personnel to 71st Evac Hospital. (Info from S3 air) Bird had a crew of 4 and 6 packs.

They fled to the northwest, one fell and they believe they hit him.

When they came down the trail towards the element one of my men bolted his rifle. One enemy heard this and dove into the brush. My man fired at his and the other VC/NVA returned 3 AK rounds. We also threw about 3 frags (1 dud), swept the area with negative findings.

1120 hours (C) S1 to BN CO: Reference to line #5 June Roster from B Co; status changes from WIA to KIA at 1515H 2 July at 12th AF Hospital.

1135 hours (C) TOC to D Co: Informed D Co that EM who was WIA on C/A yesterday was line #42.

1910 hours (C) A Co to TOC: 21 element at ZA107531 has movement across blue line to the northeast, more than one individual, also movement in water, azimuth 300 degrees, preparing to employ Arty.

1957 hours (C) B Co 23 (2nd platoon) element heard 5 tubes popping, 4 impacted 150 meters due south outside 23s perimeter. Suspected enemy location ZA111491, 113495 employed organics at this time, working up Arty. A Co 1/35, D Co 1/35, B 2/35 all had ATs that plotted basically the same place as sells sent in by B Co 23 element.

2015 hours (C) Arty being employed for B Co 23.

2049 hours (C) Recon 21 heard AK fire 1 click north of ZA153563, seen approximately at ZA152573 advised them to fire Arty.

2105 hours (C) LZ Ruth received small arms at this time.

2200 hours (C) Readout on contact at LZ Ruth: 2105H small arms received, contact initiated by enemy on northeast side of perimeter by AK-47 and shifted to the north a little, 6 to 8 individuals were on the north, northeast side of the perimeter 200 meters to the north side of the perimeter in the tree line. There were 5 individuals shifted to the southeast firing AK-47s and they fled to the east. During this time we received 4 B40s that impacted on the north side of the perimeter, 2 impacted inside the perimeter. 2145H contact broken, B40s were fired from the enemy location on the north, northeast.

Estimate we received 350 to 400 small arms rounds. We employed Arty, firecrackers. No friendly casualties, negative enemy casualties know of at this time.

1220 hours (C) A Co to TOC: ZA101533 we found 15 bunkers, 1 kitchen with 2 holes in ground for fires. All were 2 to 3 man with overhead cover 2 feet logs, dirt. No recent use. ZA106535 found 5 bunkers 3 x 3 x 5 1 feet overhead cover logs, dirt, 1 foxhole 2 x 3 x 4 feet used during past week, 2 latrines.

1100 hours (C) TOC to Bde: Blackjack 12 reported ground to air fire south, southeast of LZ Ruth from sell ZA170510. Altitude and speed unknown, we had negative hits.

1416 hours (U) DELAYED ENTRY On 5 July 69 at 1400H from 2/35 to TOC: 2/35 Aloha 13 with S3 aboard received 7 to 8 rounds AK-47 fire vicinity ZA178507, Arty was requested and adjusted in the area. B 2/35 23 element is sweeping at vicinity ZA164511 and will be sweeping in that area. They have a FO with that element.

1420 hours (C) D Co to TOC: Resupply bird, Alligator 443 on 335 degree azimuth, click from A Co; 310 degree azimuth, 600 meters which is approximate grid 090547 received small arms at 1425 hours. Slick returned fire and was fired at while returning fire. Arty trying to plan.

1604 hours (C) Our resupply bird while enroute to A Co location spotted an estimated platoon of dinks, 1 ran into the tree line 5 to 8 clicks away west of LZ Ruth. A Co ZA102510.

1721 hours (C) Alligator 443 received automatic weapons fire vicinity 153506 approximately 5 individuals. 21, 23 and 94 moving.

1030 hours (C) A Co to TOC: At Za109547 found 2 bunkers estimate 1 to 2 months old, 1 bunker would hold 4 to 5 people, 1 bunker would hold 5 to 8 people, both has 2 feet overhead cover, logs and dirt. They will destroy them.

1155 hours (C) B Co to TOC: 231 element at 097520 found 1 bunker 4 x 4 x 5 feet deep, 2 feet

overhead cover, logs and dirt with bamboo camouflage. It was partially caved in, estimate 2 months old, set up to cover an open field.

1455 hours (C) B Co while checking the area where their 21 element fired on 4 individuals this a.m. found what appeared to be a rest site. Estimate a platoon of enemy pulled into the area this morning and were there as last as 3 hours ago. They found impact area of the M79 rounds fired this morning. Also they found 6 ponchos, flashlights, jug with 12 yards of khaki clothing, parts of paper and envelopes with no writing, several miscellaneous pieces of web gear such as first aid pouches, pistol belts, etc. Appeared the enemy left the area in a hurry leaving items behind. Several trails (fresh) going south with 2 fresh blood trails also going south. Also found 10-lbs. rice in a sandbag and a small amount of salt.

(They had the man, weapon he was carrying, 2 maps with 2 LRRP AOs (CM: 0462, 0654), two LRRP bodies found at ZA053537 from team 3D and one LRRP still MIA (Reference 9 Feb 1969), one was grids and boxes marked, on the other it had no markings, individual did not have the time to fire at the OP.) They shot him first, fatigues, black pajamas bottoms, Ho Chi Minh sandals, 2 magazines AK-47, GI gas mask carrier with no mask, GI compass,

GI pistol belt, trenching tool, cigarette carrier full. Individual was Vietnamese at the west side of the perimeter, 15 meters from the OP, coming from the west on a trail when the Co employed Arty.

1515 hours (C) 2nd platoon B Co vicinity ZA113254 found a north to south trail used in the last week. At vicinity ZA113522 a trail to the west begins. Both 1 foot wide. The 1st platoon found an east to west trail 2 feet wide, which runs from ZA118517 to ZA114523. On the east side of the river is a small footpath. At vicinity ZA115521 1st platoon found a way station large enough for 20 individuals, bamboo tables 4 x 3, trench line 2 x 5, running east to west. Also found 2 well used trails (southwest to northeast, northwest to southeast), footbridge crossing a stream, At vicinity ZA114524 they found another way station for 20 individuals with bamboo tables. There were fresh campfires, opened C-ration cans, US plastic sandbags. Rations seemed to be used by the enemy. A well used trail east to west let to a bunker complex vicinity ZA117521 having 6 bunkers 4 x 5 x 4 with 3 feet overhead cover logs and dirt, 5 camp fires estimate 48 hours old and a trail leading west. Vicinity ZA116522 they found 8 square bamboo clumps, 1 Montagnard jug, 2 metal boxes 6 x 10 x 4 used in the last 2 weeks. Vicinity ZA114525 they found barefoot prints estimate 2 hours old on the east to west trail. Vicinity ZA111527 found 2 bunkers 4 x 4 x 5 with 3 feet overhead cover used in the last 3 months. Vicinity ZA114527 found 2 bunkers 4 x 4 x 5 used in the last 2 months. Entire area and bunkers were destroyed.
